We would like to inform you that the NPort IA5000 and NPort IA5000A will reach its End of Life (EoL) phase, starting May 01, 2026.

This transition is driven by two critical priorities:

- 1. Futureproof Cybersecurity Resilience:** As global security standards intensify, legacy hardware faces inherent limitations in addressing modern cyberthreats. The NPort IA5000-G2 is IEC 62443-4-1/-4-2 compliant, providing the robust, hardware-level security required for today's mission-critical networks and performance that's ready for future upgrades.
- 2. Long-term Supply Sustainability:** To uphold our commitment to long-term availability, we are migrating to new G2 platforms with more sustainable component life cycles. This move mitigates the risks associated with aging key components and ensures a stable supply for your future expansions.

The End of Service (EoS) date will be March 31, 2033.
